## About the UMKC Expungement Clinic

### What Services Do We Offer?

- Preliminary eligibility screenings
- Representation in expungement proceedings
- Limited assistance for those filing for expungement pro se
- Educational materials on Missouri's expungement law
- Assistance in directing individuals to re-entry resources

### Do You Qualify for Our Services?

Our Clinic only represents individuals who:

- Are currently eligible for a Missouri expungement
- Cannot afford to hire a lawyer, AND
- Are likely to receive a real benefit from obtaining an expungement (meaning an expungement is likely to change their ability to find suitable employment, housing, etc.).

### Do You Have to Pay Anything?

While you do not have to pay for our services, the court may require you to pay fees that can total up to \$450 per an expungement case. But if the court finds you are unable to pay, the fee may be waived. Our clinic will assess your finances to determine if you will have to pay the fee or not.

### How Long Does the Process Take?

It varies from court to court, but generally it takes 2.5 to 6 months from the time the petition is filed for the court to issue an order.

## About Expungement:

### Expungement Benefits:

- Record is not available to the general public.
- In most situations, it is as if the offense and conviction never occurred.
- You can legally say you were never convicted of the expunged offense on most applications for employment, housing, aid, etc.

### Expungement Limitations:

- Record is not destroyed, it's sealed.
- Record is still available to courts, law enforcement, government agencies and employers in certain industries like childcare, elder care, finance, banking, law enforcement, etc.
- Doesn't force commercial background check sites to remove your record from their reports.

## Are you eligible for a Missouri expungement?

Under current Missouri law, to successfully obtain an expungement and get your criminal record "cleared," you must meet the following requirements:

- (1) The offense or offenses on your record that you want expunged are eligible
- (2) Expungement would not cause you to exceed the legal lifetime expungement limit of ONE felony and TWO misdemeanor offenses total.
  - Note: Offenses charged in the same case count as only one for purposes of calculating lifetime limits (counts as the highest leveled offense in the case).
  - Note: You can get an unlimited number of infractions expunged, if they are not the "substantial equivalent of an ineligible offense."
- (3) You have satisfied the "Clean Waiting Period"
  - For felonies — at least 3 years have passed since you completed your sentence, and in the past 3 years, you cannot have been found guilty of any misdemeanor or felony offense(s) (excluding traffic violations).
  - For misdemeanors — same requirements as felonies, but one-year clean waiting period instead of three.
- (4) You do not still owe any fines, court costs, fees, or restitution on the case(s) you want to expunge.
- (5) You do not have any charges pending.
  - Note: Active warrants and unpaid traffic tickets = charges pending
