Including a Bequest to the Kansas City Public Library

When you inform the Kansas City Public Library of your legacy gift, you are helping us to prepare for the years ahead! In addition, you give us an opportunity to express our appreciation and invite you to become a member of the Greenwood Society as a legacy member.

If you already have a will, you can add a bequest to the Kansas City Public Library by means of a simple document called a codicil. In some cases, donors who have revocable living trusts choose to make a future gift to the Foundation through the equivalent of a bequest, namely a charitable distribution provision in the trust agreement. Usually, an existing trust agreement can easily be amended to include such a provision. Please make sure to reach out to your attorney for assistance with your legacy gift.
