Free Tax Preparation Services

Internal Revenue Services

For filing in 2026, eight private-sector partners are offering guided tax software products through IRS Free File to taxpayers with an adjusted gross income of \$89,000 or less in 2025.

Understanding IRS Free File

Each IRS Free File trusted partner sets its own eligibility requirements, which may include age, income, state residency, and military status. Some partners also offer free state tax return preparation and filing. Claim tax credits are no cost.

IRS Free File allows eligible taxpayers to claim valuable tax benefits, including earned income tax credit, the child tax credit, and other refundable credits. Refundable tax credits can reduce the amount of tax owed or result in a refund, even if no tax is due.

Kansas City Metro Tax Coalition

The IRS offers free basic tax return preparation to people who qualify through the Volunteer Income Tax Assistance (VITA) and Tax Counseling for the Elderly (TCE) programs. To qualify, one or more of the following must be true: You must make under \$69,000/year, be more than 60 years old, have a disability, or have a limited proficiency in English.

Help with Tax Issues

Free legal resources are available to help low-income families with tax-related problems from prior years. Assistance can include helping respond to IRS audits, establishing payment plans, and other options.

Kansas City Tax Clinic

The Kansas City Tax Clinic provides free legal services for tax disputes with the Internal Revenue Service for individuals meeting certain income qualifications. Law students, supervised by former IRS attorneys, provide valuable services to the public at no charge while increasing their experience in the practice of tax law.
